## Who are we?

DDK Positioning is a provider of enhanced GNSS Augmentation Solution. Our services can be utilised in a number of markets, including offshore survey & construction, maritime, agriculture and defence.

## How do we collect information from you?

We obtain information about you when you use our website, for example, when you complete the contact form, when you complete the site registration form, purchase a product from our store or engage with other forms within our site.

## What type of information is collected from you?

The personal information we collect might include your name, address, email address, IP address, and information regarding what pages are accessed and when.

## Use of 'cookies'

Like many other websites, the company name website uses cookies. 'Cookies' are small pieces of information sent by an organisation to your computer and stored on your hard drive to allow that website to recognise you when you visit.
